COURSE DETAILS: When comprehensively planning the worn, damaged or missing dentition it can be difficult to know "where to start." As life expectancy increases and the demographic of our senior population continues to grow, the need for more extensive rehabilitations will similarly increase. With advancements in dental implant technology and clinical techniques, it can also become confusing when to salvage a patient's remaining dentition or consider an "All-on-4" to replace what may be a terminal set of teeth. Many of your patients will rely on you for guidance, even if you are not providing this type of care.
